#### Recommendations

1. The Calendar of Board of Management and Board Committee meetings for 2021-22, is presented for consideration of potential alterations.

#### 1. Purpose

The attached paper is the current version of the Calendar of Board of Management and Board Committee meetings for 2021-22. The Committee will consider any changes prior to recirculation to the Board.

#### 2. Key Insights

#### 2.1 Context

The Calendar has been prepared with reference to previous CoGC Board and GCRB Calendars, the regular cycle of meetings, and the requirement for a number of approvals and submissions relating to the College's planning, reporting, and approvals cycle.

In summary the Calendar consists of:

- Six meetings of the full Board of Management, including two all-day planning events (November 10th 2021 and February 23rd 2022). The first of these dates clashes with COP26 in Glasgow, and consideration should be given to a reschedule of the November Board Planning event. (n.b. COP 26 dates are 31st October - 12th November).
- Four meetings of the Performance and Nominations Committee (PNC) between Board meetings (to facilitate delegated Board decisions/ approvals) including one summer meeting on 11 August to oversee preparations for extended campus return. N.b. membership of PNC comprises Committee Conveners.
- 3. Three meetings of the Remuneration Committee; membership of this Committee also comprises Committee Conveners.
- 4. A regular cycle of Board Committee meetings preceding full Board meetings, with, where possible, a minimum two-week interval between the end of the Committee cycle and the full Board meeting, as per established practice.
- 5. Meeting arrangements have been made as per session 2020-21, with all meeting set up via MSTeams. However, it is expected that arrangements will be made to have "hybrid" Board meetings i.e. with at least some Board members in attendance on campus. Meeting times have also been carried forward from 2019-20.

#### 3. Impact and implications

The pattern of meetings ensures a cycle of reportage from College Board Committees to the full Board, and related approvals, while meeting the Board's other obligations.
