1. Recommendations

3. Consultations

3.1 This paper is shared with the Performance & Nominations Committee for discussion and decision ahead of tabling at the Board's meeting in June for approval.

4. Key Insights

4.1 The Performance & Nominations Committee receive the draft Board schedule ahead of it being tabled at the Board for approval at its final meeting of the academic year.

4.2 The draft Board schedule tabled for the Committee's consideration is largely based on previous years and informed the committee structure that the Board indicated a preference for at its most recent meeting. All meeting cycles end with a quarterly meeting of the Board.

4.3 The Board currently has two strategic planning events each year. It is proposed that one strategic planning session be held in November and a Board development day be held in April. These bi-annual sessions were all-day events pre-Covid. Members are also asked if they are content with these sessions returning to all-day events.

4.4 At present, Board meetings are not scheduled to follow the Board development and strategic planning session; however, instead, it is proposed that they can be scheduled if necessary throughout the year.

5. Impact and Implications

5.1 The proposed schedule of meetings ensures a cycle of reportage from the committees to the Board and factors in key activities and requirements throughout the academic year, such as the annual report and accounts.
