#### 4. Key Insights

4.1 The Performance & Nominations Committee considered the draft Board and committee schedule for the forthcoming academic year at its meeting in April. Members agreed to recommend the schedule to the Board for approval

4.2 The schedule tabled for the Board's approval is largely based on previous years and informed the committee structure that the Board indicated a preference for at its meeting in April. All meeting cycles end with a quarterly meeting of the Board.

4.3 The Board currently has two strategic planning events each year. It is proposed that one strategic planning session be held in November and a Board development day be held in April. These bi-annual sessions were all-day events pre-Covid.

4.4 Board meetings in the schedule are not arranged to follow the Board development and strategic planning session by default; however, instead, it is proposed that they can be scheduled if necessary throughout the year.

#### 5. Impact and Implications

5.1 The proposed schedule of meetings ensures a cycle of reportage from the committees to the Board and factors in key activities and requirements throughout the academic year, such as the annual report and accounts.
