## 1. Recommendations

## 2. Purpose

The purpose of this paper is to update the Committee on the standards of the College's health and safety performance and to provide a platform for the Committee to demonstrate their ongoing commitment to the effective management of health and safety.

The health and safety reporting process involved a production of a monthly health and safety report to be presented to the Health and Safety Committee, Senior Management Team and subsequently to the People and Culture Committee. This paper provides monthly reports produced from data and health and safety activity covering August 2024 and September 2024.

## **3.**Consultation

The Health and Safety Monthly Reports are shared with the Senior Management Team and Executive Leadership team each month. The reports are a standing item for consultation and feedback with the Health and Safety Committee and our Trade Union Colleagues.

#### 4. Key Insights

#### 4.1 Executive Summary

This paper details the monthly Health and Safety reports for August and September 2024.

During these two months, 27 accidents were recorded, 2 of which were RIDDOR reportable. Additionally, there were 2 incidents. All RIDDOR reportable accidents were investigated by the Health and Safety Team. Remedial actions taken included a review of risk assessment control measures, increased supervision, and additional instruction and training.

In August, the Health and Safety Manager participated in the Association of Colleges Benchmarking Exercise. The results from this exercise will significantly align with the data provided in the Health and Safety Annual Report for September. A comprehensive report from the Association of Colleges is expected in November.

Fire Risk Assessments were conducted across both campuses and Halls of Residence during this period. The resulting reports and action plans are scheduled for release in October.

An unannounced out-of-hours fire drill was conducted on 17th September at Riverside Halls of Residence, followed by an announced fire evacuation drill at City Campus on the 26th of September. Full reports and debriefs have been completed, detailing the roles of specific individuals, and outlining action plans.

The Fire Safety Officer, with the support of the Health and Safety Team, is responsible for completing Personal Emergency Evacuation Plans (PEEPs). A total of 100 PEEP requests were received, and all individuals have been contacted and provided with the relevant guidance. The Health and Safety Team will work alongside the Fire Safety Officer to coordinate and schedule necessary meetings.






The month of August 2024 saw 7 accident and 1 incident, none of which were RIDDOR reportable.










### 4.2 Accident/Incident Data – Comparison Charts


A comparison of accident and incident data is provided below. There was an increase of 7 accident/incidents this academic month compared to 2023/2024





First Aid Treatments Only (non-work related)






In September 2024, there were **21 accidents and 1 incident**, with two of the accidents being RIDDOR-reportable. These incidents met the RIDDOR criteria as both students were transported directly from the accident site to the hospital for treatment. One accident involved improper handling of sharps, resulting in butterfly stitches, while the other was caused by machinery.


The Health and Safety Team has thoroughly investigated both cases. One investigation has been concluded, with the student receiving refresher training and additional supervision. The machinery involved in the second accident remains out of service as the team works with the Faculty to review and implement potential machinery modifications.






## 4.2 Accident/Incident Data – Comparison Charts


It is important to note that the rise in reported cases can be attributed to a lower volume of practical work conducted during the 2022/2023 academic year, primarily due to industrial strike action.







## 6. Fire

## 6.1 September Fire Statistics

An Engineering Cadet caused excessive smoke and minor flames by reheating pizza in its box within the oven. A fire blanket was used to extinguish the flames, and an incident report was completed.

A replacement FAAST unit (smoke detector) was triggered by minor cooking fumes, leading to a full evacuation of the Halls of Residence (HoRs). To address the issue, the sensitivity of the unit was reduced by FES to prevent further false alarms. Following the activation and subsequent meetings with the Scottish Fire and Rescue Service (SFRS), the following actions were agreed upon:

- Radios will be provided to Persons in Charge (PICs) and HoR staff.
- Loudhailers will be made available for HoR staff.
- Immediate rectification of a fault with the first barrier, which was not interfaced with the fire alarm system, is required.
